I am at least 18 years of age. I am an independent sales consultant of EclipseSpa and not an employee. I understand that any income is based on my efforts to sell EclipseSpa organic and natural spa products and no salary is guaranteed.

I will not misrepresent EclipseSpa in any way. Any misrepresentation is subject to immediate termination. EclipseSpa will provide product training documentation to fully understand the use and benefits of their products. To stay active, you must have placed an order within 60 days.

Confidentiality/Trade Secrets: Rep shall not disclose any of the secrets, methods or systems used by EclipseSpa in its business. All customer and client lists, brochures, reports, marketing materials and other such information of any nature shall be held in strict confidence.

Expenses/Costs: Rep shall bear any and all costs or expenses incurred by Rep to perform the duties and obligations hereunder, including, but not limited to vehicle, travel expenses, insurance and office expenses

Taxes: I understand I am responsible for all income taxes from my commissions in my state according to the Dept. of Revenue. I am also responsible for reporting any income from EclipseSpa to the state and IRS. EclipseSpa will provide Rep a 1099 form reflecting all commissions paid annually if the commission reaches \$600.00

Commission Structure:

- A. 30% for the first \$2500 in retail orders.
- B. After \$2500 has been met in retail orders, the commission will be upgraded to 35%.
- C. Commission excludes freight/shipping charges.

- D. Any earning's previously paid to rep for product shipped, but subsequently returned or for product which becomes uncollectible will be deducted from Reps commission unless the product was defective.
- E. While it is not required, if you refer 2 sales consultants to EclipseSpa you will receive a \$75.00 bonus for each consultant after they have achieved 2 months of commissionable sales. You are welcome to refer more than two consultants.

Payment: Commissions are paid after product has been delivered to recipient. Payments are paid by check or through PayPal

Miscellaneous: All amendments shall be in writing and signed by EclipseSpa and Rep. The construction, validity and performance of this Agreement shall be governed by the laws of the State of California. This Agreement constitutes the entire Agreement of the parties.

I have carefully read the polices and procedures in regard to becoming an EclipseSpa Spa at Home Sales consultant. I understand that I have a right to terminate my agreement anytime by submitting so in writing and may cancel this transaction within three business days from the date of this transaction.
